- ii. Detail of Technical Staff on roll with their CV's and copies of certificates / degrees and registration with PEC, where required. (Attach copy of last pay roll).
- iii. Detail of works of similar nature executed during last five years with necessary evidences.
- iv. Detail of running works in hand with progress & performance certificates from employer.
- v. Detail of machinery, equipment with ownership proof.
- vi. Certificate to the effect that the firm is not involved in litigation with any department (Duly attested by Notary Public) including RDA.
- vii. Financial status with bank references and satisfactory audit balance sheets for the last three years duly certified by Chartered Accountants Supported by Income Tax paid and detail of immovable properties owned by the firm and its Directors.
- viii. Certification from the concerned departments that the works of similar nature executed by the firms were completed in stipulated period to the entire satisfaction of the Department / Client.
- ix. Registration with Pakistan Engineering Council valid upto **31.12.2011** in appropriate class.
- x. The National Tax Number of the firm along with a copy of the last Income Tax returns.
- xi. Any other information deemed necessary by the firm.
- xii. All the documents, papers, certificates provided for prequalification shall be duly signed by the proprietor of firm or authorized person with official seal.
