3. Tender rates and amount should be filled in figures as well as and tender should be signed as per general directions given in the tender documents.
4. Tenders documents will be issued during office hours on **28-03-2011** and will be received on **30-03-2011** at **11:30** a.m. which will be opened immediately thereafter by the tender opening committee in the presence of intending contractors or their authorized representatives.
5. Conditional tenders and tenders not accompanied with earnest money in shape of Deposit at Call Receipt from Scheduled Bank and attested copies of registered partnership deed and power of attorney in case of firms will not be entertained.
6. As per Finance Department Punjab Notification No.RO (Tech) 1-2-83 (VI) (P) dated 06-04-2005. If the total tendered amount will be less than 5% of the approved estimate (DNIT) amount, the lowest bidder will have to deposit additional performance security issued by any scheduled bank in favour of undersigned for the amount so reduced within 15 days of issue of notice or expiry period of bid / tendered whichever is earliest.
7. The undersigned shall have right of rejecting any or all of the tenders without assigning any reasons thereof.
8. Tenders at serial # 1,2 & 3 will issued to only those firms/contractor's who are specialized in the relevant field & will produce poof that they have at least completed three similar nature works of equivalent value.
